## The real question isn't whether Inclisiran reduces LDL cholesterol - but whether Inclisiran reduces coronary artery disease. Re: UK deal over inclisiran

The real answer about the benefit of Inclisiran, or any lipid-lowering drug - or for that matter any dietary recommendation(s) made for LowCarb-Keto, Vegan, AHA or other dietary proposals — isn't whether the drug or diet lowers LDL cholesterol or triglyceride levels, or increases HDL cholesterol levels, or lowers CRP.

The real question to be answered is whether these drugs or diets have an impact at the tissue level – i.e. the coronary arteries; where the inflammatory process impairs coronary blood flow [1] eventually resulting in angina [2] and ultimately myocardial infarction and death.

More than two decades after first presenting the "Inflammation and Heart Disease" and "Angina" Theories [1-4], the discussion of the treatment of coronary artery disease continues to revolve around blood tests and weight loss. When the expected or desired changes in blood tests do not occur, purported pundits merely declare that cholesterol and saturated fat are a myth — demonstrating either a complete lack of understanding of the Inflammation Theory itself [3] or a failure to actually read it. Reminding us of the adage "I can teach it to you but I cannot understand it for you."

Mere measurement of these blood tests is only mildly to moderately "correlated" with actual changes in coronary artery disease (CAD) itself [5], and the resulting change in physiologic function [1] responsible for the symptomatic development of angina [1-4].

We would agree that a well designed study on the effect of Inclisiran – or again any drug or diet, which proposes that the impact of the drug or diet on CAD is a reduction in CAD – is needed. Such a study; however, must quantify the effect upon the coronary arteries themselves [6,7] and not merely look at blood tests, changes in weight or some qualitative interpretation [7,8]. Anything less is merely guesstimating [7].
